Dress Code and Rules of Conduct



The OUTreach Center Youth Prom will be held at the University of Antelope Valley's Grand Ballroom on Saturday, May 12, 2018 from 8pm to 11pm. The prom is open to all students who are in grades 9-12 and their dates aged 14-20. To attend, all students must show a current 2017-2018 high school ID and must complete and submit the Contact Information and Attendee Acknowledgement form. Additionally, students under the age of 18 must submit the accompanying Parent/Legal Guardian Permission portion. Dates of students who are no longer in high school but are 20 or younger must show government issued IDs.

Food and drinks are included with ticket purchases. ALL SALES ARE FINAL. Tickets are non-refundable and non-transferrable. Forms and student or state identification are DUE AT THE DOOR and are required to enter the event.

Dress Code:

- Formal attire is requested; semi-formal or theme appropriate costumes are accepted
- Inappropriate dress will result in a student or guest not being allowed into the prom
- No slits or dresses shorter than the mid-thigh
- Bare midriffs are not allowed
- No sheer/see-through material from mid-thigh to bust area
- No jeans
- No exposed undergarments
- No overly revealing body parts
- Footwear Required
- No canes or chains, bandanas, or head rags or baseball caps allowed

Conduct:

Attendees agree to behave appropriately at The OUTreach Center Youth Prom. Attendees must adhere to all rules set forth and instructions from OUTreach Center directors. Dancing in a manner that is inappropriate or dangerous to themselves or others will be subject to removal from the event. If an attendee is under the age of 18, the parent or legal guardian must pick up the minor immediately after the prom. Bullying or any other form of discrimination or intimidation will not be tolerated. This event is tobacco, alcohol, and drug free. THERE WILL BE NO RE-ENTRANCE TO PROM. IF YOU LEAVE THE EVENT, YOU CANNOT COME BACK IN.

Prohibited Items:

Security and chaperons reserve the right to check all attendees prior to entering the event and again with reasonable suspicion. DO NOT bring the below listed items; doing so could lead to confiscation of the item and/or removal from the event. Confiscated items will not be returned.

- Alcohol or flasks
- All tobacco products
- Any illegal substances
- Canes & zoot chains
- Lighters or matches
- Sharp objects including pocketknives
- Wallet chains
- Weapons: guns, knives, etc.
- Pencils, markers, or pens
- Body sprays/perfume/cologne, or nail polish
- Mouthwash, breath spray, or other liquid items
- No glass bottles of any kind
- NO OUTSIDE FOOD OR DRINKS including water bottles
